The Government of India has received a loan from the International Bank for Reconstruction & Development towards the cost of Andhra Pradesh Water Sector Improvement Project and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding is open to all bidders from eligible source countries as defined in the *IBRD Guidelines for Procurement*. Bidders from India should, however, be registered with the Government of Andhra Pradesh or other State Government/Government of India, or State/Central Government Undertakings. Bidders are advised to note the minimum qualification criteria specified in Clause 5 of the instructions to Bidders to qualify for the award of the contract.
2. The Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta invites bids for the construction of works detailed in the table. The bidders may submit bids for any or all of the works indicated in the table below.
3. Bidding documents (and additional copies) may be purchased from the office of the Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta **from 03.11.2017 to 04.12.2017** for a non-refundable fee (three sets) as indicated, in the form of cash or Demand Draft on any Scheduled bank payable at **Vijayawada in favour of Pay & Accounts Officer, Works & Projects, Vijayawada**. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs.1000/-. The Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
4. Bids must be accompanied by security of the amount specified for the work in the table below, drawn in favour of Pay & Accounts Officer, Works & Projects, **Vijayawada**, in case of demand draft or the Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta in case of bank guarantee. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
5. Bids must be delivered to the office of the Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta on or before **15.00 hours** on **05.12.2017** and will be opened **on the same day at 15.30 hours**, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
6. A pre-bid meeting will be held **on 17.11.2017 at 11.00 hrs.** at the office of the Superintending Engineer, Pulichintala Project Circle, Jaggayyapeta to clarify

the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 10.2 of 'Instructions to Bidders' of the bidding document.


